#### Hello Neighbors

Our first HOA meeting of 2018 was held on At the November board meeting a cease and February 13 @ Glenwood Elementary. As was requested by a homeowner we held a Town Hall meeting prior to the official business meeting. The purpose was to have an open dialogue regarding the ongoing BMP cleanup and to answer any questions from homeowners.

Main concerns were: Damage to existing lawns by contractors during any cleanup.

The delay of clean up. The window for cleaning up while the trees are still bare and grass dormant is coming to a close.

Water treatment that is on hold until the banks are cleaned up.

All of these are valid concerns and are being addressed. Any additional comments or concerns may be addressed with the board.

To give a short recap on the BMP status:

desist letter from Thompson Law Group who is representing four individual homeowners was presented to the board. This prevented the board from moving forward with any contracting of a landscaping company.

The board forwarded the letter to Inman and Strickler, which is the law firm that represents the HOA. They issued a reply to the Thompson Law Group. Both letters can be found on the HOA website.

At the February HOA meeting the board was prepared to move forward with the reviewing and selecting a contractor as we had not heard back from Mr. Thompson. However, the board was informed by Donald Darcy, whom Mr. Thompson represents that a reply was forthcoming. Until this information could be confirmed with the attorneys, the board placed the vote on hold. Homeowners will be kept apprised of any developments.

I was appointed to the board 1 year ago and agreed to serve the community to the best of my ability. Your faith and trust in me has not gone unappreciated and I thank you.

Unfortunately I find that due to my current work schedule I can no longer be an effective representative for our community due to the amount of time that is necessary to devote to the ongoing matters.

- 1. During Homeowner Forum, all comments will be addressed to the board. No other homeowner should comment unless called upon by the speaker to clarify. Homeowners will remain respectful at all times.
- 2. Homeowner Forum will be limited to 3 minutes per speaker. Those who request speaking time are asked to sign up prior to the meeting's call to order. A sheet will be provided.
- 3. Upon closing of Homeowner Forum all further discussion will take place by the board members. They may call on a homeowner for input however at no other time should homeowners interrupt or interject.
- 4. Board members during discussions shall each have an opportunity to weigh in with their opinions or suggestions. Each board member shall be given the opportunity to speak when discussing a topic. Board members shall remain respectful to others in attendance at all times. If needed, a second round of discussions will take place once everyone has the chance to weigh in.

Applications are to be received in the Association Office no later than the twentieth (20) of the month in order to be reviewed at the next ARB meeting, which is one week prior to the Board meeting. Any application received after the twentieth will be reviewed at the next subsequent meeting.
