### KICKING IT IN THE KITCHEN

Ham and Swiss Sliders

Ingredients:

24 Slices of deli honey ham
6 Slices of swiss cheese, cut
into fourths
1/3 cup Mayonnaise
1 tablespoon Poppy seeds

1 1/2 tbsp. Dijon mustard

1/2 cup Butter melted

1 tablespoon Onion Powder
1/2 tspWorcestershire sauce
2 packages (12 count) KING'S
HAWAIIAN Original Hawaiian
Sweet Dinner Rolls

Cut rolls in half and spread mayo onto 1 side of the rolls. Place a slice or two of ham and slice of swiss cheese in roll. Replace the top of the rolls and bunch them closely together into a baking dish.

Step 2 In a medium bowl, whisk together poppy seeds, dijon mustard, melted butter, onion powder and worcestershire sauce.

Step 3 Pour sauce over the rolls, just covering the tops. Cover with foil and let sit for 10 minutes.

Step 4 Bake at 350 degrees for 10 minutes or until cheese is melted. Uncover and cook for additional 2 minutes until tops are slightly browned and crisp. Serve warm.

## KUDO'S TO THE KIDS

Our first Kid Spotlight is on not 1 but 2 exceptional IRF kids. Connor Bradley and Kaitlyn Wilms along with 5 of their teammates recently competed against 13 teams and took 2nd place in the First Lego League Regional Competition. This accomplishment advances them to the State Competition where they will compete against 104 teams. This will take place on December 2 and 3 @ JMU.

First Lego League or FLL is an international competition organized for elementary and middle school students. Over the course of 8 weeks the kids work together to free build a robot using legos and various program attachments.

Connor and Kaitlyn participate in FLL through Brickheadz which is an enrichment center located in Chesapeake that teaches kids model building, robotics and build and play skills.

For the competition the kids, utilizing EV3 Mind Storm software, designed, built and automated their robot, Rover.

The competition is broken into 4 catagories.

- 1. Core Values
- 2. Robot Design
- 3. Robot Performance
- 4. Research Topic/Project

The core values teach sportsmanship and team professionalism. For the next 2 components, they had to master skills in coding, calibrating, using a gyro sensor and troubleshooting.

Whew!! But it didn't stop there.
This year's theme is:
Hydrodynamics.

For this portion the kids were challenged to come up with an innovative idea or an improvement on an existing design. The team chose to focus on gray water.

I was a bit clueless about gray water but Connor and Kaitlyn quickly educated me. Gray water is any used household water that is free of any contaminates.

This water can be recycled using a Gray Water System.

This water can then be used for plant irrigation, laundry and even bathing. This can significantly reduce our footprint on our planet!

The problem the kids identified is that in order for water to be treated in a gray water system it must be contaminate free. Many of the household items we use, such as laundry detergents and soaps, contain contaminates.

The kids focused on a way to make it easier for consumers to know which products are free of contaminates. They designed a universal symbol that can be placed on all household products that are safe to be used with a Gray Water system. When wandering the grocery aisles you would simply choose your product and look for the Universal Symbol on the label.

Now that you are fluent in Gray Water, let's get back to Connor and Kaitlyn. I asked both what they liked best about Brickheadz. Connor said he enjoys being with friends and Kaitlyn's favorite part is creating.

We wish both of these terrific kids the best of luck at their upcoming competition. Give them a big thumbs up when you see them!

- 1. During Homeowner Forum, all comments will be addressed to the board. No other homeowner should comment unless called upon by the speaker to clarify. Homeowners will remain respectful at all times.
- 2. Homeowner Forum will be limited to 3 minutes per speaker. Those who request speaking time are asked to sign up prior to the meeting's call to order. A sheet will be provided.
- 3. Upon closing of Homeowner Forum all further discussion will take place by the board members. They may call on a homeowner for input however at no other time should homeowners interrupt or interject.
- 4. Board members during discussions shall each have an opportunity to weigh in with their opinions or suggestions. Each board member shall be given the opportunity to speak when discussing a topic. Board members shall remain respectful to others in attendance at all times. If needed, a second round of discussions will take place once everyone has the chance to weigh in.
