ARB UPDATES

Our HOA Manager is revising the Exterior Alteration Application. The main change is that all applications submitted will be reviewed and a decision rendered by the ARB within 30 days of submission. Please note that if additional information is required on a specific application, the 30 days begin once the requested information is submitted. The ARB reviews all applications submitted via email. This is meant to expedite the decision making process. However, if the ARB has questions or they can't come to a unanimous decision, they may request a meeting with the homeowner. All applications are reviewed in compliance with our community's Declaration and Rules and Regulations. BMP UPDATE

SPOOKY SNACKS

Antipasto Eyeballs: take mozzarella balls and make a small slit in the center. Instert pimiento-stuffed olives.

Wrap in prosciutto. Serve with crostini

Sausage Axes: cut small wedges of kielbasa; fry in an oiled skillet. Pierce with a sharp chopstick and insert a thin breadstick. Serve with ketchup, bbg sauce for your bloody ax.

Ghost Crackers and Dip: Brush wonton wrappers on both sides with melted butter. Fit each into a mini muffin cup. Bake @ 350, 5-7 minutes. Let cool and draw eyes with edible marker.

Puree a 15oz can each of pumpkin puree and drained chickpeas, 1/4 cup each tahini, water and olive oil. 1 garlic clove, juice of 1 lemon, 1 tsp each salt, cumin and 1/4 tsp cayenne. Serve with your ghost crackers.

Our HOA Attorney served the City of Virginia Beach in an attempt to get a Declaratory Judgement as to who they would hold responsible for our BMP maintenance. They had a deadline of September 25 in which to respond. They did respond however they declined to give a determination. The position that they continue to hold is that if the city finds it necessary to issue a fine then they will issue it to both the homeowner and the HOA. This would then force a court to decide since both can not be held responsible.

At this time our attorney is preparing discovery to proceed to court to have a judge made a determination.

Upon submission to the court, the judge will have 30 days to issue a decision. This could be done in 2 ways. 1. All discovery is submitted, the judge reviews and issues a decision. 2. The judge will have both parties appear (our attorney and the city attorney) to present their case. This will be open to any homeowner to attend but no homeowner will be allowed to speak per court procedure. If it is the latter all homeowners will be notified of the date by mail.

Meetings will take place on the second Tuesday of the meeting months. With the exception of the September meeting which is considered the annual meeting and is held on a Saturday.

Meetings begin @ 6:30pm and are held @ Glenwood Elementary. If any changes are made homeowners will be notified.

Meetings may be attended by any person residing in Indian River Farms.

There is a homeowner forum at the beginning of each meeting for any one who wishes to speak on a topic. Each homeowner is given 3 minutes to speak. If time permits additional time may be allotted.

Here are some key objectives for all meetings.

- 1. During Homeowner Forum all comments will be addressed to the board. No other homeowner should comment unless called upon by the speaker to clarify. Homeowners will remain respectful at all times.
- Homeowner Forum will be limited to 3 minutes per speaker. Those who request speaking time are asked to sign up prior to the meeting's call to order. A sheet will be provided.
- 3. Upon closing of Homeowner Forum all further discussion will take place by the board members. They may call on a homeowner for input however at no other time should homeowners interrupt or interject. If a homeowner has something to add that is pertinent they are asked to raise their hand and wait to be acknowledged.
- 4. Board members during discussions shall each have an opportunity to weigh in. Each board member shall be given the opportunity to speak when discussing a topic. Board members shall remain respectful to others in attendance at all times. If needed, a second round of discussions will take place once everyone has the chance to weigh in.
